#### CERTIFICATION FOR DETERMINATION OF PROBABLE CAUSE

That MARK R. LARSON is a Deputy Prosecuting Attorney for King County and is familiar with the police report and investigation conducted in King County Police Department case No. 87-145125;

That this case contains the following upon which this motion for the determination of probable cause is made;

Havalah Baldik is the three-year-old daughter of the defendant, George Baldik. Havalah lives with her mother, father and brother at 3730 S. 142nd, Seattle, King County, Washington, 98168.

On July 1, 1987, the defendant returned home from work at 10:30 p.m. He picked up Havalah from her bed and took her to a bedroom in another part of the home. The defendant placed her in a bed and attempted penile-vaginal intercourse with his daughter.

The following morning, Havalah complained to her mother of vaginal soreness. Havalah indicated that the defendant had "tickled" her on "my owie spot", pointing to her vaginal area. Mrs. Baldik found that Havalah was bleeding from the vagina. Havalah was then taken to Harborview Medical Center for treatment. Social worker, Joan Ward, spoke to Havalah at Harborview Medical Center. Havalah told her that the defendant had done the same thing three times in the past week and that "now my bottom hurts."

The defendant was contacted by Detective Daly on July 9, 1987. In an interview, the defendant admitted that it was possible that he had done what his daughter described, stating that "my little girl knows what she is talking about."

Due to the seriousness of this offense, bail is requested in the amount of \$5,000. Furthermore, the defendant should be prohibited from having contact with the victim, or any other minor children without supervision of a responsible adult.
