15 THIS MATTER having come on for hearing on plaintiff's
16 Motion and Order to Show Cause directed to the defendants,
17 the Court having read and considered the written briefs,
18 declarations, and other supporting materials filed by the
19 parties and the files and records herein, the Court having
20 heard and considered the arguments of counsel, and good
21 cause appearing; and it further appearing that a preliminary
22 injunction should issue herein to maintain the status quo as
23 the same existed on March 3, 1988 with regards to the plain-
24 tiff and Community Chapel and Bible Training Center (herein
25 "Community Chapel"), and the evidence indicating that the
26 defendants held meetings and took action individually and as
members of the Board of Directors of Community Chapel
regarding the Articles of Incorporation, the Bylaws, and

2 Community Chapel without authority, notice to or the con-
3 currence of the plaintiff as required by the corporation
4 procedures, now, therefore, it is hereby

5 ORDERED, ADJUDGED AND DECREED that the defendants, their
6 agents, servants, employees, and attorneys, and those per-
7 sons in active concert or participation with them who
8 receive actual notice of the order by personal service or
9 otherwise be, and they hereby are, RESTRAINED AND ENJOINED
10 during the pendency of this action, both individually and
11 collectively as the Board of Senior Elders of the Community
12 Chapel and Bible Training Center as follows:

13 1. From taking any action or causing and other person
14 to take any action which would interfere with the plain-
15 tiff's performance of the functions and duties of the
16 following positions of the Community Chapel and Bible
17 Training Center as they existed on March 3, 1988:

- 18 a) President;
- 19 b) Chairman of the Board of Senior Elders;
- 20 c) Pastor of the corporation church;
- 21 d) President and Chief Administrator of Community
22 Chapel Bible College;
- 23 e) Chief Executive Officer of the Community Chapel
24 Christian School;
- 25 f) Chief Executive Officer of the Community Chapel
26 Publication;

1 g) Chief Executive Officer of the Community Chapel
2 Communications; and

3 h) Member of the Community Chapel and Bible
4 Training Center.

5 2. From doing or performing any act contrary to or in
6 contravention of the terms and conditions of the Articles of
7 Incorporation and Articles of Faith and Bylaws of the
8 Community Chapel and Bible Training Center as they existed
9 on March 3, 1988; and

10 3. From destroying, damaging, removing, secreting,
11 selling, or encumbering the files, records, notes, tape
12 recordings or any other property, whether real or personal,
13 belonging to the Community Chapel and Bible Training Center;
14 and it is further

15 ORDERED, ADJUDGED AND DECREED that this ~~Injunction and~~ ^{Restraint} ~~and~~ P
16 Restraining order shall become effective upon the plaintiff
17 filing with the Clerk of this Court a bond, either cash or
18 surety, in the amount of Five Thousand Dollars (\$5,000.00)
19 for the payment of such costs and damages as may be incurred
20 or suffered by any party who is found to have been wrong-
21 fully enjoined or restrained, which bond has been filed by
22 plaintiff on March 11, 1988; and it is further

23 ORDERED that the Clerk is directed to acknowledge
24 receipt on the bottom of this Order upon deposit of the bond
25 as provided herein.


